DPC has revised the flu talking points to reflect the President's comments last night.

### **Emergency Use of unlicensed Influenza Vaccine from other Countries**

●□□□□□□ President Bush has directed our public health officials to do everything they can to make sure people who need the shot the most ...our children and the elderly ... get the shot. We have a record of achievement in this area:

■.... The President is the first President to develop a stockpile of the flu shot. We contracted for the first time to have available approximately 4.5 million doses that we could provide to children. In addition, we are purchasing and stockpiling the drugs that will be needed to treat people that get the flu.

■.... We have increased overall funding for flu preparedness from \$47 million in 2002 to a proposed budget of \$283 million for FY 2005.

■.... We have invested heavily in our public health infrastructure since I became President. The massive effort to protect the American people from another terrorist attack is paying dividends, because we have dramatically increased funding for our public health system nationwide. The results: For the first time CDC is going to be able to track supply and demand – we will know by county where priority populations are and match that to our supply of flu vaccine in that county.

■.... The President believes we can and should do more. He believe we must invest in next generation vaccine development to guarantee a year-round influenza vaccine capacity. These new technologies use cell-cultures instead of chickens and eggs. He has called on Congress to act in this area.

clock to help ensure that people who need the flu shot the most get the shot. They are considering all options. One option is using vaccines that are available in other countries but that are unlicensed in this country, but that option would be used only in the case of an unusual flu season.
