FOIA 2014-0337-F requested materials related to records created by or sent to Robert Portman, Director of the Office of Management and Budget (OMB), on issues relating to securities regulation, market regulation, and the Securities and Exchange Commission (SEC).

This FOIA primarily contains copies of an email with an article and related information regarding an SEC decision on executive compensation, a macro brief economic report from MKM Partners LLC, a House floor update, an OMB nightly report, and news headlines.

System of Arrangement

The materials in FOIA 2014-0337-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
