#### **Scope and Content**

The materials in FOIA 2017-0364-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2017-0364-F requested materials related to documents issued by the Office of the Solicitor or the Office of the Secretary within the Department of the Interior regarding the alteration, rescission, withdrawal, or repeal of any national monument designated under the Antiquities Act.

This FOIA primarily contains correspondence, filed legal documents, print-outs from Westlaw, texts of bills, a summary and Q&A, published reports, and administrative documents such as fax cover sheets and cover memoranda. Correspondence includes letters between President George W. Bush and Utah Governor Michael Leavitt regarding the San Rafael Swell as well as a letter to Secretary of the Interior Gale Norton on the same matter. Electronic records consist of a list of national monuments established by Presidential Proclamation and a statement on H.R. 2114, the National Monument Fairness Act.

### **System of Arrangement**

The materials in FOIA 2017-0364-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
