#### **Scope and Content**

The materials in FOIA 2014-0123-F[1] are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0123-F[1] contains materials related to Harriet E. Miers' nomination and withdrawal to the United States Supreme Court.

This first segment of this FOIA primarily contains production documents provided to supplement Miers' responses to the Senate Judiciary Committee Questionnaire. Each section of the Questionnaire corresponds to 28 tabs arranged accordingly. Dated from 1986 through 2005, the production documents within Tabs 1 through 28 consist of Miers' biographical and professional history. Tabs 1 through 9 cover Miers' biography, education, employment record, and awards and distinctions. Tabs 10 and 11 include production documents related to Miers' membership activities and offices held with the Dallas Bar Association, Dallas Bar Foundation, Texas State

Bar Association, Texas Bar Foundation, and American Bar Association, such as meeting minutes, newsletters, journal editorials, directories, policy manuals, conference programs, reports, rules and guidance information, correspondence, and memoranda (Boxes 9-13 and 16-26 contain duplicate materials). Tabs 12 and 14 canvas Miers' community leadership, civic contributions and affiliations, and elected and appointed public offices held. As a member of the Dallas City Council, Dallas Firemen and Police Fund Commission, and Texas Lottery Commission, among others, production documents consist of membership applications, attendance records, agendas, meeting minutes, transcripts, memoranda, correspondence, and reports. Financial Disclosure forms are included as well. Also present are published writings, such as articles, editorial pieces, and White House fact sheets and Statements of Administration Policy that Miers wrote. Miers' speeches found in Tab 13 include public statements, remarks from judicial swearing-in ceremonies, conference papers, commencement addresses, and award acceptances. Speech topics cover leadership roles, economic development in Texas, and women and law (Boxes 28, 34, and 35 contain duplicate materials). Tabs 15 through 28 cover Miers' legal career as well as the judicial nomination and selection process. Production documents pertain to Miers' practice of law, legal philosophy, teaching law, counsel position and court experience, and pro bono work. Production documents related to constitutional law litigation (First Amendment, Due Process, Full Faith and Credit, Voting Rights, Twelfth Amendment, and Separation of Powers) are present. A majority of the production documents consist of court case records, such as proceedings, briefings, and opinions, from Miers' practice before local and district courts, the Texas State Supreme Court, and the United States Supreme Court. In addition, some of Miers' drafted responses to the Questionnaire are among the production documents.

### **System of Arrangement**

The materials in FOIA 2014-0123-F[1] are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
