This FOIA primarily contains photographs taken during the June 14, 2004 visit by the Clinton family to the White House. The photographs consist of posed group shots of the Clintons with the White House Residence staff at the North Portico. Also included are candid shots of the Clintons greeting and talking with various members of the staff.
