**Abstract:** White House Office of Records Management Subject Files relating to parks and maintained during the administration of George W. Bush.

**Access:** Access to Bush Presidential Records is governed by the Presidential Records Act (PRA) (44 USC 22) and the Freedom of Information Act (FOIA) (5 USC 552 as amended) and therefore records may be restricted in whole or part in accordance with legal exemptions.

**Copyright:** Documents in this collection that were prepared by officials of the United States government as part of their official duties are in the public domain. Researchers are advised to consult the copyright law of the United States (Title 17, USC) which governs the making of photocopies or other reproductions of copyrighted material.

**Custodial History:** Official records of George W. Bush's presidency are housed at the George W. Bush Presidential Library and administered by the National Archives and Records Administration (NARA) under the provisions of the Presidential Records Act (PRA).

**Administrative History:** The White House Office of Records Management is responsible for the filing and retrieval of records created during the incumbent presidential administration. The use of a filing methodology for records created or received by the White House dates to at least the early years of the 20<sup>th</sup> century, and has undergone changes since that time to cope with the ever-expanding volume of paperwork handled by the President and his staff.

The White House Office of Records Management, or ORM (or WHORM) manages the office files of individual White House staff members, as well as administration records that are arranged by subject code and case file ID number according to their general subject matter.

**Scope and Content Note:** This series consist of correspondence, memoranda, routing sheets, proclamations, statements, internet printouts, email printouts, talking points, press releases, fact sheets, newspaper clippings, fliers, reports, and drafts thereof. Correspondence includes letters to President George W. Bush from members of Congress and the general public regarding the designation of lands as national parks or national monuments, responses to the general public from the Department of Interior regarding concerns about various parks and monuments, views letters from the Department of Interior making recommendations to President George W. Bush regarding proposed national parks and monuments, and letters from the general public regarding memorials to victims of the September 11<sup>th</sup> terrorist attacks, including but not limited to, a designated gravesite at Arlington National Cemetery and a memorial park in New York City. A considerable amount of material, including letters from the general public, agency views letters, proclamations, supporting documentation about the monument lands, and press releases are present related to Governors Island National Monument, the National World War II Memorial, the African Burial Ground National Monument, the Northwestern Hawaiian Islands Marine National Monument (later renamed the Papahānaumokuākea Marine National Monument), and the World War II Valor in the Pacific National Monument. Also present are a memorandum from President George W. Bush approving the burial of the last known surviving United States Army veteran of World War I, Frank Buckles, at Arlington National Cemetery, and a memorandum directing the Secretaries of Defense and the Interior to study the potential Pearl Harbor National Monument. Draft statements included in this series consist of a tribute to former Senator Paul Coverdell, and a ceremony honoring the Navajo Code Talkers. Also present are fact sheets and handouts on the 14<sup>th</sup> National Marine Sanctuary, the National Parks Legacy Project, and Strengthening and Caring for America’s National Parks. Various National Park Service reports are present, as well as the 2007 Department of the Interior report “The Future of America’s National Parks.”

**System of Arrangement:** Material is arranged by alphanumeric subcode and thereunder by case file number.
