## APPOINTMENTS TO INTELLECTUAL PROPERTY TASK FORCE

WASHINGTON, D.C. - Attorney General Alberto R. Gonzales today announced the appointment of several high-level Department of Justice officials to serve on the Department's Task Force on Intellectual Property.

The Task Force was created in 2004 by then-Attorney General John Ashcroft to examine the Department's efforts to protect the intellectual property rights of American citizens and businesses through criminal, civil, and antitrust enforcement; legislation; international coordination; and prevention. In October 2004, the Task Force issued a comprehensive report with recommendations to increase the Department's effectiveness in protecting intellectual property rights and enforcing federal intellectual property laws.

In February 2005, Attorney General Gonzales renewed the Department's commitment to the IP Task Force and appointed Kyle Sampson as Chairman and Arif Alikhan as Vice Chairman and Executive Director. The Attorney General also announced that the Department would implement all of the IP Task Force report's recommendations and would continue to aggressively enforce federal intellectual property laws.


