Scope and Content

The materials in FOIA 2014-0108-F[1] are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0108-F[1] contains materials related to correspondence sent to President George W. Bush on vacancies within the Federal District Courts, Federal Courts of Appeal, and the United States Supreme Court.

The first segment of this FOIA primarily contains memoranda; letters to the President from nominees, supporters, and Members of Congress; and background material that accompanies the correspondence such as resumes, candidate writing samples, news articles, data on judicial

nominations from past administrations, public relations materials disseminated by the White House (i.e. talking points and letters of support), and case law on people being suggested or nominated for judicial posts.

System of Arrangement

The materials in FOIA 2014-0108-F[1] are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in this collection area – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
