Scope and Content

The materials in FOIA 2014-0130-F[1] are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0130-F[1] requested materials related to Valerie Wilson, also known as Valerie Plame, or to her husband, Joseph C. Wilson IV.

The first segment of this FOIA primarily contains news clippings and press briefing transcripts related to Valerie Plame Wilson, correspondence with journalists regarding the Plame investigation and subsequent court cases, correspondence with members of the general public about the Plame investigation, publicly available documents relating to Congressional hearings and investigations, and publicly filed documents in various court cases related to Valerie Plame Wilson. The court cases include: In Re: Grand Jury Subpoena, Judith Miller; United States v. I.

Lewis Libby Jr.; Valerie Plame Wilson, *et al.* v. I. Lewis Libby Jr., *et al.*; Committee on the Judiciary of the United States House of Representatives v. Harriet Miers and Joshua B. Bolten; and Citizens for Responsibility and Ethics in Washington v. Executive Office of the President, *et al.*

Also included are press pool reports, talking points, invitations to public events, excerpts from published reports, lists of FOIA requests pending at Executive Branch agencies, letters from members of Congress and summaries thereof, lists of upcoming legislative activities, and questions for the record submitted by members of Congress to individuals nominated for office or to the judiciary. These records date between January 1, 2003 and January 20, 2009.

System of Arrangement

The materials in FOIA 2014-0130-F[1] are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
