FOIA 2014-0200-F contains emails sent to or from members of the George W. Bush administration from 2007 to 2008 that mention the Nevada Democratic Fox News Debate.

This FOIA primarily contains emails relating to news articles, news summaries, newsletters, blogs, weekly columns and television program notifications. Also included are emails containing a Congressional Quarterly political calendar and a petition from ColorOfChange.org.

System of Arrangement

The materials in FOIA 2014-0200-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
