FOIA 2014-0215-F[2] requested records sent to, sent by, or received by President George W. Bush regarding al Qaeda and Osama bin Laden from January 2001 to January 2009.

The second segment of this FOIA primarily contains correspondence from members of Congress, military families, and other constituents. Additional material includes press releases,

news reports, transmittal and routine memoranda, cover sheets, fax cover sheets, and printed emails.

It should be noted that many of the documents listed here have been closed due to National Security classification and/or exemptions of the Freedom of Information Act.

Please note that a portion of classified records related to this request has not yet been processed. Additional records will be provided as they become available.

System of Arrangement

The materials in FOIA 2014-0215-F[2] are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
