Scope and Content

The materials in FOIA 2014-0235-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0235-F requested records sent to, sent by, or received by President George W. Bush, as well as closed press video materials, regarding the terrorist attacks on September 11, 2001, the aftermath of 9/11, the Joint Intelligence Committee Inquiry (JICI) of 9/11, Osama bin Laden, al-Qaeda, Saudi Arabia, Saudi nationals, Saudis who left the United States after 9/11, and Prince Bandar bin Sultan, between January 2001 and March 2003.

This FOIA primarily contains video clips of routine photo ops, meetings, and events. Included are a South Lawn arrival via Marine One, photo ops with boxer Johnny Ruiz and Teacher of the Year Kathy Black, a meeting with the Saudi Ambassador to the United States, a meeting with the Foreign Minister of Saudi Arabia, and a Hanukkah reception. Also included is b-roll footage of damaged areas after the September 11th terrorist attacks, including Ground Zero on 9/19/2001 and the Pentagon on 9/11/2001 and 9/14/2001.

Textual records consist of general correspondence, routing memoranda, reports and printed material. Included are copies of President George W. Bush's February 7, 2002 memorandum "Humane Treatment of al Qaeda and Taliban Detainees," condolence letters from Prince Bandar bin Sultan and King Fahd bin Abdulaziz Al-Saud, a Federal Register notice regarding Executive Order 13224, copies of both the "National Strategy for Combating Terrorism" and "9/11 Five Years Later: Successes and Challenges" and a transcript of Ari Fleischer's August 28, 2002 press gaggle regarding Prince Bandar bin Sultan's visit to Crawford, TX.

System of Arrangement

The materials in FOIA 2014-0235-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
