#### **Scope and Content**

The materials in FOIA 2014-0355-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0355-F contains all records created by or sent to Arthur Levitt, Chairman of the Securities and Exchange Commission.

This FOIA primarily contains correspondence, resumes, and supporting documents related to employment in the White House and presidential appointments across the federal government. Letters sent by Arthur Levitt can be located in folders entitled "450209," "479722 Folder 3 [4]," and "641835 Katja Bullock Folder 2 [2]."

#### **System of Arrangement**

The materials in FOIA 2014-0355-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Alpha Files.

WHORM Subject and WHORM Alpha Files are processed at the document level.

The WHORM Alpha File was compiled by the White House Office of Records Management and is a series of documents arranged by name of persons, organizations, or events.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
