This FOIA primarily contains correspondence from multiple organizations. Topics of the correspondence include the African Literature Association urging the President to change US policies towards Somalia after passing a resolution at its annual meeting, the circulation of a letter regarding financial issues to the members of a G-20 meeting, solidarity concerning the financial crisis, and the United Nations Convention on the Rights of the Child.
