This FOIA primarily contains correspondence and materials from organizations, WAVES information for a meeting, schedules, and calendars. It consists of a message to the members of the House Armed Services Committee concerning legislation from the Coalition on Outsourcing and Privatization, WAVES information for meeting with Julia Susman, an email forwarding new contact information to Julia Susman, and a message from the organization Ducks Unlimited with

materials preparing for an annual dinner and auction. Also included are calendars and schedules for members of the Cabinet in November 2006 and December 2006.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
