Scope and Content

The materials in FOIA 2014-0459-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0459-F requested materials related to the nomination and confirmation of Stephen C. Robinson as a U.S. District Judge for the Southern District of New York.

This FOIA primarily contains resumes, biographical information, fax cover sheets, routine memoranda, routing memoranda, correspondence, formal nomination paperwork, press releases, charts, and printed legal cases. The resumes and biographical information are from various approved nominees for judicial appointments. Documents relating to Robinson's appointment include the formal nomination sent to Congress, the memorandum to President Bush approving

Robinson's nomination, as well as biographical information. Correspondence includes letters from President Bush to various newly appointed judges, letters from Congress requesting the appointment of nominees, and letters from current judges informing the White House of their intent to retire.

Electronic records consist of spreadsheets tracking the confirmation process of judicial nominees, lists of the minority judges nominated by President Bush, reports on the status of judicial nominations, compilations of news articles, copies of a press release from Senator Chuck Schumer's office, daily whip notice updates regarding occurrences in Congress, and emails regarding the submission of paperwork for nominations.

System of Arrangement

The materials in FOIA 2014-0459-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files, Staff Member and Office Files, and George W. Bush Presidential Electronic Records.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu

Staff Member and Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
