BIOGRAPHY OF JUDGE DAVID S. CERCONO

Judge David Stewart Cercone (5th District) was born [REDACTED] in Stowe Township, the son of Richard D. and Margaret (Stewart) Cercone. He graduated from Sto-Rox High School in 1970, Westminster College (B.A. magna cum laude) in 1974 and Duquesne Law School (J.D.) in 1977.

Judge Cercone was a judicial law clerk in Common Pleas Court in 1978, an assistant district attorney in Allegheny County from 1979 to 1981, and a District Justice from 1982 to 1985.

He is a member of the Allegheny County Bar Association, Pennsylvania Conference of State Trial Judges, ISDA, and Board of Directors of Boys & Girls Club of Western Pennsylvania. He is also a part-time faculty member at the University of Pittsburgh and Robert Morris College. He serves on the Board of Visitors for the Graduate School of Public and International Affairs, University of Pittsburgh.

Judge Cercone received the Distinguished Alumni Award from Westminster College in 1989, Teacher of the Year Award from the Graduate School of Public and International Affairs, University of Pittsburgh, was named 1994 Man of the Year in Law by the Italian Heritage Society and received the 1994 Citation for Professional Achievement from Westminster College.

Judge Cercone was elected Judge, Court of Common Pleas, in November, 1985 and was appointed Administrative Judge of Criminal Division by Pennsylvania Supreme Court, in December, 1993. At age 32, he was the youngest person ever elected to the Allegheny County Court of Common Pleas.

Judge Cercone is married to Mary Ann Kraus (District Justice) and has three sons, Spencer, Stephen and Christopher. The Cercones reside at [REDACTED]
