Brett,

We spoke earlier this week about the releasability under the FOIA of certain documents in the Department of Energy's custody. I briefly described the documents in question to you and you told me that, for FOIA purposes, they were DOE documents and that DOE could make a determination as to their releasability.

However, the last document I have been able to find that addresses the issue, a Memorandum sent by Associate Attorney General Webster L. Hubbell on November 3, 1993, clearly states that, "records originating with any part of the ' White House Office ' should be forwarded to the Office of the Council to the President for any recommendation or comment it may wish to make..."

The documents attached to this e-mail are draft letters from a White House Office that were sent to the Secretary of Energy for his information. Each contains the statements, "I have shared your letter with the President's advisers and the appropriate agencies who are formulating policy recommendations in this area. Your comments are receiving their close and careful attention."

Since we do not have a copy of the final letter that may have been sent by the White House, we wanted to clarify what your position is for draft documents that the Department may have in its custody that originated at the White House. Is it the policy of your office that draft letters that contain statements above, regardless of the subject matter content, sent to the Secretary for his information may be released by the Department under the FOIA?
