



## Exchange Email - Presidential

### Press Releases – May and June 2006

**Date Ranges:** May 1-23, 2006 and June 1-15, 2006.

**Extent and Forms of Material:** 15,573 email messages.

**Abstract:** The email messages in this subseries contain press releases that were sent to the press, White House staff, and members of the public through the [Press.Releases@Whitehouse.gov](mailto:Press.Releases@Whitehouse.gov) email address in the months of May and June 2006.

**Scope and Content Note:** Electronic records are stored within the Electronic Records Archive (ERA) as Search and Access Sets (SAS). The Exchange Email SAS is comprised of email messages sent between January 20, 2001 and January 20, 2009. The Exchange Email SAS contains multiple copies of messages sent or received by staff members within the White House, so there are a large number of duplicative emails within the Press Releases – May and June 2006 subseries.

The Press Releases series consists of email messages sent from the [Press.Releases@Whitehouse.gov](mailto:Press.Releases@Whitehouse.gov) email address. The range of dates processed as part of this subseries includes May 1, 2006 to May 23, 2006 and June 1, 2006 to June 15, 2006. The Press Releases include press schedules of President George W. Bush, Vice President Richard B. Cheney, and First Lady Laura Bush, as well as Executive Orders, fact sheets, memoranda, messages, notices, personnel announcements, press briefings, proclamations, speeches, and statements.

The email messages in the subseries were released under processing ID 2013-0119-E. Released email messages will be made available through the National Archives' Online Public Access Catalog, or OPA.

**System of Arrangement:** The Press Releases – May and June 2006 subseries is a part of a larger series, which contains all email sent and received by the [Press.Releases@Whitehouse.gov](mailto:Press.Releases@Whitehouse.gov) email address. This subseries was arranged chronologically by date.
