Help them be their best selves, so that they are able to discern what is accurate and true. Fill them with your tough and tender love so that what they do and say is in harmony with your will.

Only you in your wisdom know the way to achieve lasting peace that is rooted in justice and mercy. Help each of us, but especially our President, leaders of other nations and all their advisors discern what that wisdom is.

Enable all of us and each of us to live as Jesus was teaching us to live, when he taught us to pray: “Our Father”
