FOIA 2019-0300-F requested all textual materials relating to Michael Einik with subject lines pertaining to "Kosovo," "Kosovo Liberation Army," "Macedonia," "Former Yugoslav Republic of Macedonia," "Yugoslavia," "Serbia," "Serbia-Montenegro," "NLA," "National Liberation Army," "Ali Ahmeti," "Skopje," "Southern Serbia," "Preševo Valley," and "UÇPMB" from January 21, 2001 to September 30, 2001, and November 1, 2004 to November 20, 2004.

This FOIA primarily contains National Security Council (NSC) profile sheets, routine memoranda, and distribution sheets.

# System of Arrangement

The materials in FOIA 2019-0300-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
