This FOIA primarily contains photographs created by staff photographers from the White House Photo Office on April 9, 2007 taken at the U.S. Border Patrol – Yuma Station Headquarters in Arizona before, during and after remarks by President George W. Bush on Comprehensive Immigration Reform. This request also includes one selected master tape from the White House Television Office (WHTV). WHTV 6352: Remarks on Comprehensive Immigration Reform, has a run time of 00:39:37 and contains one clip consisting of Remarks on Comprehensive Immigration Reform.

System of Arrangement

The materials in FOIA 2015-0089-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files and George W. Bush Presidential Electronic Records.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of video tapes that are not wholly responsive to the subject area.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program.
