Scope and Content

The materials in FOIA 2016-0020-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0020-F requested photographs from September 10-17, 2001.

This FOIA primarily contains photographs of various events from September 10 to 17, 2001. Events from September 10 include a visit to Justina Road Elementary School in Jacksonville, Florida.

Events from September 11 include White House Communications Agency activities in Anacostia, Washington, D.C., including views of smoke from the Pentagon; White House Staff aboard Air Force One throughout the day; Mrs. Laura Bush visiting Sen. Ted Kennedy in his

office, delivering remarks, and holding with staff at Secret Service headquarters; press and others on the street after the White House is evacuated; Karen Hughes delivering remarks from the FBI; Joe Hagin and staff in New York City; staff at the White House upon the return of the President; senior staff meetings at the White House; and a press briefing by Ari Fleischer.

Events from September 12 include President George W. Bush meeting with senior staff, National Security Council meetings, a joint congressional meeting, Karen Hughes meeting with staff, a First Lady's staff meeting, and a press briefing by Air Fleischer. The President also speaks on the phone with world leaders and visits the Pentagon with Secretary Donald Rumsfeld to survey the damage, meet with the Joint Chiefs of Staff, and greet rescue workers and Pentagon employees. Mrs. Laura Bush visits Walter Reed Hospital and an American Red Cross blood drive.

Events from September 13 include President George W. Bush speaking on the phone with world leaders as well as New York Governor George Pataki and New York City Mayor Rudolph Giuliani, and the President meeting with staff and members of Congress. Mrs. Laura Bush is interviewed by the media and the President and Mrs. Bush visit the Washington Hospital Center. There are also views of a candlelight prayer vigil near the U.S. Capitol.

Events from September 14 include a cabinet meeting, speech preparation, and a situation room meeting at the White House. President George W. Bush and Mrs. Laura Bush attend the National Day of Prayer and Remembrance. Also pictured are President George H.W. Bush and Mrs. Barbara Bush, and President Bill Clinton, Senator Hillary Rodham Clinton and Chelsea Clinton. President George W. Bush then tours Ground Zero in New York City. He takes an aerial tour of the disaster site, greets firefighters, police and rescue personnel, uses a bullhorn to address the crowd, and visits with FEMA workers and families of missing and deceased.

From September 15-16, President George W. Bush takes a working trip to Camp David, holding national security meetings and delivering his weekly radio address. On September 17, the President holds staff meetings at the White House, visits the Pentagon, and visits the Islamic Center of Washington. Mrs. Laura Bush attends a memorial service in Pennsylvania for those who died on United Flight 93.
