#### **Scope and Content**

The materials in FOIA 2016-0039-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0039-F requested materials related to W. Michael McCabe.

This FOIA primarily contain schedules, routine briefings, resumes, web printouts, published articles, speech drafts, and routing memos. Also included are various documents related to the appointment of Linda Fisher vice W. Michael McCabe to the Environmental Protection Agency. The electronic records consist of articles, press releases, lists of Clinton recess appointments, and materials for the PFOA (perfluorooctanoic acid) ECA (enforceable consent agreement) Telomer Technical Subgroup meetings with the EPA. Most emails mention Mr. McCabe in the context of Clinton recess appointments and the nomination of Linda Fisher vice W. Michael McCabe.

Emails directly from Michael McCabe include a 2008 message of thanks to James Connaughton and a 2002 email regarding a meeting and Earth 911.

#### **System of Arrangement**

The materials in FOIA 2016-0039-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and George W. Bush Presidential Electronic Records.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
