Scope and Content

The materials in FOIA 2016-0046-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0046-F requested materials related to the event at the Inter-American Development Bank on March 14, 2002.

This FOIA contains research materials, speech drafts, schedules, printed emails, published reports, news articles, website printouts, fax cover sheets, routing memos, briefings, fact sheets, statements, and barcode scanning sheets. The majority of this request consists of material relating to the drafting of the speech given by President George W. Bush at the Inter-American Development Bank on March 14, 2002 such as speech drafts, reports and statistics on various

countries, published reports regarding economics and global development, printed emails confirming numbers and statistics, facts provided by government agencies and the National Security Council, and news articles. Also included are briefings and schedules for the various events occurring on March 14, 2002.

System of Arrangement

The materials in FOIA 2016-0046-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
