FOIA 2016-0057-F requested materials related to all emails between Dana Perino and journalist Mike Allen, from January 1, 2007 to January 20, 2009.

This FOIA primarily contains articles, requests for interviews with President George W. Bush and White House staff, notes of appreciation, draft articles and pieces for Politico, and requests for comment or information. The majority of records are from Mike Allen to Dana Perino, with her replies.

System of Arrangement

The materials in FOIA 2016-0057-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
