### Scope and Content

FOIA 2016-0097-F requested materials related to raw video footage of President George W. Bush giving his Address to the Nation from the Oval Office on September 11, 2001.

This FOIA primarily contains video footage of President George W. Bush in the Oval Office in the moments before, during, and after his Address to the Nation on the evening of September 11, 2001.

#### System of Arrangement

The materials in FOIA 2016-0097-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
