Scope and Content

The materials in FOIA 2016-0129-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0129-F requested materials related to five Radio Days conducted by the White House, limited to particular collections and series.

This FOIA primarily contains barcode scanning sheets, schedules, printed photos, printed email, briefing papers, background materials, talking points, Q and As, biographies of radio hosts and administration personnel, reports, routine memoranda, correspondence, and invitations. These Radio Days include 10/30/2002 at the White House, 01/21/2004 at the White House, 04/06/2005 at the Department of Treasury, 09/11/2006 at the Pentagon, and 10/24/2006 at the White House. Documents specifically related to these radio days include schedules of interviews, booking

assignments, biographies of radio hosts and administration staff being interviewed, talking points and background materials, routine memoranda requesting participation in Radio Day, congratulatory letters, and planning documents. Mainly included are briefing binders for White House staff. Records related to participation in the Pentagon's Third Radio Day on 09/11/2006 include an invitation from Donald Rumsfeld to Josh Bolten. Also present are schedules, correspondence, and invitations for the Chief of Staff.

System of Arrangement

The materials in FOIA 2016-0129-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
