#### **Scope and Content**

The materials in FOIA 2016-0180-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0180-F requested textual materials related to speeches given by President George W. Bush in Riga, Latvia on May 7, 2005.

This FOIA primarily contains background materials relating to the drafting of speeches given by President George W. Bush in Riga, Latvia on May 7, 2005. This material includes internet printouts, talking points, administrative printed emails, copies of past speeches given by President George W. Bush, copies of remarks by Secretary of State Colin Powell, National Security Advisor Stephen Hadley, and Ambassador Clifford Sobel, background reports related to

the trip to Riga, Latvia, schedules, press releases, Q&As, letters from President George W. Bush to world leaders in Latvia and Estonia, and printed emails regarding fact-checking details mentioned in the speeches and trip planning. Also included are administrative documents such as barcode scanning sheets, NSC profile sheets and routing memos.

## **System of Arrangement**

The materials in FOIA 2016-0180-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
