Scope and Content

The materials in FOIA 2016-0230-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0230-F requested textual records related to the Presidential Advisory Council on HIV/AIDS (PACHA), 2002-2003. This request also included textual records related to the resignation of Patricia Ware as the executive director of PACHA and the potential nomination of Jerry Thacker to serve on PACHA; however, no responsive records were located.

This FOIA primarily contains draft and final talking points, lists, printed emails, briefings, schedules, correspondence, agendas, and administrative documents such as fax cover sheets, routing memos, and barcode scanning sheets. There are various documents related to the

members of PACHA such as resumes and lists; agendas, planning documents, and related material from various PACHA meetings; guest lists and administrative documents such as Worker and Visitor Entry System (WAVES) records for a White House PACHA event; printed emails scheduling conference PACHA calls; and printouts from the PACHA website such as a report and member contact information lists. Also included are briefing papers and schedules for the presidential events of January 29, 2003 and April 29, 2003.

System of Arrangement

The materials in FOIA 2016-0230-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member Office Files.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available in our research room and on our website at www.georgewbushlibrary.smu.edu.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
