Scope and Content

The materials in FOIA 2016-0243-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0243-F requested materials related to internal government emails pertaining to or referencing Donald Trump or Trump Organization during the second term of President George W. Bush.

This FOIA primarily contains articles, a congressional hearing witness list, "you're fired" and related anecdotes, emails referencing past winners of *The Apprentice* such as Kelly Perdue, and emails regarding a gift from Donald Trump to President George W. Bush. A large portion of these materials relate to a gift from Donald Trump to President George W. Bush, including logistics, delivery, tracking, and coordination regarding the gift and letter, as well as a thank you

letter from President George W. Bush for the gift. Also present is information regarding testimony provided by Donald Trump in 2005 to the Senate Homeland Security and Governmental Affairs Committee Subcommittee on Federal Financial Management, Government Information, and International Security regarding the renovation of U.N. headquarters.

System of Arrangement

The materials in FOIA 2016-0243-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
