Scope and Content

The materials in FOIA 2016-0244-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0244-F requested materials related to internal government emails pertaining to or referencing Donald Trump or Trump Organization during President Bush's first term in office, 2001-2005.

This FOIA primarily contains emails sharing articles about or discussing "The Apprentice" and/or Donald Trump, emails containing jokes or cultural references related to Donald Trump, emails regarding events that Donald Trump attended, services offered by Donald Trump to the George W. Bush administration, projects contributed to by Donald Trump, polls referencing Donald Trump, and one spreadsheet containing the Vice President's Christmas card list.

System of Arrangement

The materials in FOIA 2016-0244-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
