This FOIA primarily contains pool reports containing the menu for the dinner, a website update document containing the menu for a White House Social Dinner Honoring President Alvaro Uribe of the Republic of Colombia, and emails among White House staff containing the menu for the dinner.

#### System of Arrangement

The materials in FOIA 2018-0199-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
