Scope and Content

The materials in FOIA 2018-0018-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2018-0018-F requested White House Office of Records Management files related to John Joseph "Joe" Ricketts, Founder of TD Ameritrade.

This FOIA primarily contains correspondence from the public, birthday cards, holiday party invitations, talking points, questions from the press, federal judicial resumes, correspondence, and schedules. Correspondence consists of routine administrative correspondence between Karl Rove and the general public, universities, and White House personnel. Researchers should know that there are very few documents related to John Joseph "Joe" Ricketts and most records only

briefly mention him. Specific documents that mention John Joseph "Joe" Ricketts include a list of a Board of Trustees and a donation that provided for the purchase of books.

System of Arrangement

The materials in FOIA 2018-0018-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas: White House Office of Records Management (WHORM) Subject Files.

WHORM Subject Files are processed at the document level.
