**Biographical History**: Steven A. Atkiss earned a bachelor's degree in Political Science from the University of Florida and later completed programs at George Washington University's Graduate School of Political Management and the Institute for International Mediation and Conflict Resolution.

Mr. Atkiss served as Special Assistant to the President and Deputy Director of Advance from January 2001 – January 2004, where he was responsible for negotiating, planning, and executing the President's global travel.

In January 2004, Mr. Atkiss went on to serve as Special Assistant to the President for Operations. While there, he helped to arrange events for military, law enforcement, and civilian groups that offer support to the President.

From May 2006 to October 2007, Steve Atkiss worked for the U.S. Customs and Border Protection (CBP) as Chief of Staff. At CBP, Mr. Atkiss was an advisor on issues such as trade, security, and international affairs. He also worked to organize the relations between CBP, the White House, Department of Homeland Security, state and local governments, and the media.

Steve Atkiss is currently a Principal and founding partner of Command Consulting Group, a global security and intelligence consulting company.
