**Abstract:** Henry Lozano served as Director of USA Freedom Corps and Deputy Assistant to the President from 2007-2008. These series consist of materials pertaining to USA Freedom Corps efforts to encourage citizen engagement and volunteering.

**Biographical History**: Henry Lozano served as Director of USA Freedom Corps and Deputy Assistant to the President from September 11, 2007 – July 25, 2008. During his tenure, Mr. Lozano was responsible for coordinating with government agencies to encourage Americans to volunteer within their communities. Mr. Lozano also oversaw the creation of the volunteer.gov website which allowed organizations and volunteers to effectively connect with one another. Before coming to the White House, Mr. Lozano worked for a variety of public service organizations. From 1974-1985, Mr. Lozano served as the director of Teen Challenge, a faith-based ministry program targeting substance abuse issues. In 1985, Mr. Lozano helped organize

the first red-ribbon campaign in California to raise awareness about the dangers of drug use. Mr. Lozano was the President and Chief Executive Officer for Californians for a Drug-Free Youth, from 1996-2007. During this time, President Bill Clinton named Mr. Lozano to the Advisory Commission on Drug-free Communities in 1998; Mr. Lozano later became Co-Chair of the Commission in 2001. In 2005, Mr. Lozano was honored with the President's Call to Service Award.

After leaving the White House, Mr. Lozano became the Executive Director of the Shinnyo-en Foundation, before returning to Teen Challenge as the Director of the Los Angeles County Teen Challenge and Urban Ministries Initiative in 2011.

**Scope and Content Note:** The USA Freedom Corps office files of Henry Lozano include two sub-series: Subject Files and Travel Files. The documents to be opened are correspondence, invitations, agendas, reports, and requests for meetings at the White House from groups seeking to collaborate with USA Freedom Corps. Also included are remarks, response letters, government reports, fact sheets, memoranda, and drafts thereof addressing the activities and potential future activities of USA Freedom Corps. The Travel Files include administrative forms such as travel authorizations, expense tracking, bills and receipts from travel, agendas from the events attended, as well as correspondence between USA Freedom Corps and external organizations arranging the logistical details of White House participation in these events.

**System of Arrangement:** The collection is arranged in two series. The Subject Files are arranged alphabetically and the Travel Files are arranged chronologically.
