**Abstract:** This series consists of materials relating to the various initiatives under OFBCI including Mentoring Children of Prisoners, the Prisoner Re-Entry Initiative, Charitable Choice and CARE (Charity, Aid, Recovery, and Empowerment).

**Biographical History**: H. James (Jim) Towey, III earned a bachelor's degree from Florida State University in 1978 and proceeded to earn a Juris Doctor from Florida State University College of Law in 1981. In 1985, Mr. Towey befriended Mother Theresa of Calcutta and served as her legal counsel for 12 years. He also spent time volunteering in Mother Theresa's missions.

Inspired by Mother Theresa, Mr. Towey founded Aging with Dignity, a non-profit organization with a "mission to affirm and safeguard the human dignity of individuals as they age and to

promote better care for those near the end of life." He created Five Wishes, a popular living will, as well.

Later Mr. Towey served as legislative director and legal counsel to Republican Senator Mark Hatfield, Chairman of the United States Senate Appropriations Committee. Then Mr. Towey served in the cabinet of Florida Governor Lawton Chiles. He has earned six honorary doctorates, an award from Pope John Paul II, as well as many other honors.

James Towey served as the director of OFBCI from 2002 to 2006, where he worked to remove the barriers that discriminated against community and faith-based programs and made it difficult for them to compete for federal grants. He also worked to rally the armies of compassion.

After serving in the White House, Mr. Towey became the second president of Ave Maria University in Florida.

Subject Files consist of budget proposals, publications, research, reports, draft legislation, memos between White House advisors, emails, news-clippings, and comments regarding OFBCI initiatives. Major topics covered in the Subject Files include CARE (Charity, Aid, Recovery, and Empowerment), Charitable Choice, the Compassion Capital Fund, vouchers, Mentoring Children of Prisoners, the Prisoner Re-Entry Initiative, and faith-based organizations accomplishments.

Trip Files include Mr. Towey's trip planning documentation, such as, invitations, correspondence, itineraries, receipts, and tickets for 2002.

The General Files consist of correspondence between Mr. Towey and faith-based organizations, publications, and various information received about faith-based organizations.

**System of Arrangement:** The series is arranged into three sub-series. The first sub-series, Subject Files, is arranged alphabetically by subject. The second sub-series, Trip Files, is arranged by date. The third sub-series, General Files, is arranged by subject code.
