### **Scope and Content**

The materials in FOIA 2014-0224-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2014-0224-F requested materials sent to, sent by, or received by President George W. Bush related to *Hamdan v. Rumsfeld* from January 2002 to December 2006.

This FOIA primarily contains general correspondence, public court records, barcode scanning sheets, hand-written notes, news clippings and press releases. Also included are a copy of the appeal from the United States District Court for the District of Columbia, a schedule of congressional events regarding *Hamdan*, an agenda for a meeting with the Chief of Staff regarding *Hamdan*, a statement before the Senate Committee on the Judiciary by Steven G.

Bradbury, routine informational memoranda concerning congressional activity related to *Hamdan* from White House staff to the President, correspondence between Congress and the White House, a summary of the Supreme Court decision in *Hamdan v. Rumsfeld*, and a transcript of the June 12, 2006 episode of "The O'Reilly Factor" featuring a report on Guantanamo.

#### System of Arrangement

The materials in FOIA 2014-0224-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member Office Files and White House Office of Records Management (WHORM) Subject Files.

Staff Member Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

WHORM Subject Files are processed at the document level.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
