Scope and Content

The materials in FOIA 2015-0308-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2015-0308-F requested records from the White House Office of Presidential Personnel regarding Heidi Cruz (formerly Heidi Nelson).

This FOIA primarily contains resumes, personnel forms, fax cover sheets, job descriptions, a news article, routine printed emails, and routine post-it notes. This request mainly consists of different versions of Heidi Cruz's resume and various personnel forms. Also included is Cruz's vetting and donation information and a job description for one of her positions.

System of Arrangement

The materials in FOIA 2015-0308-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files and Staff Member and Office Files.

Staff Member and Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.

WHORM Subject and WHORM Alpha Files are processed at the document level.

The WHORM Alpha File was compiled by the White House Office of Records Management and is a series of documents arranged by name of persons, organizations, or events.

The WHORM Subject File compiled by the White House Office of Records Management is comprised of a series of documents assigned a letter/number combination and filed in a subject category.
