## **Scope and Content**

The materials in FOIA 2016-0058-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA 2016-0058-F requested personnel files related to Denise Gitsham. Gitsham worked at the White House in Agency Liaison, a component of the White House Office of Presidential Correspondence, the White House Fellows Office, and the Department of Justice.

This FOIA primarily contains administrative forms related to employment, copies of Gitsham's resume, administrative printed emails, and printed emails from Gitsham regarding her preferences on various potential positions.

### **System of Arrangement**

The materials in FOIA 2016-0058-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Staff Member and Office Files.

Staff Member and Office Files are maintained at the folder level by staff members within their individual offices and document all levels of administration activity.

Staff Member and Office Files are processed at the folder level, that is, individual documents are not selected and removed from a folder for processing. While this method maintains folder integrity, it frequently results in the incidental processing of documents that are not wholly responsive to the subject area.
