FOIA 2017-0094-F requested photographs of Marine One arrivals and departures.

This FOIA primarily contains photographs of Marine One arrivals and departures. Specific events include the arrival and departure from Chicago O'Hare International Airport and Grant Park Landing Zone in Chicago, Illinois, January 6, 2006, the arrival at Philadelphia International Airport in Philadelphia, Pennsylvania, May 24, 2006, and the departure from the Plain Landing Zone following the Commencement Address at the United States Military Academy at West Point in West Point, New York, May 27, 2006.
