Scope and Content

FOIA 2017-0142-F requested records from the White House Office of Records Management (WHORM) related to James "Jim" O'Neill.

This FOIA primarily contains unsolicited resumes and employment inquiries, unsolicited recommendations from Congress and individuals regarding staffing, drafts and the final message for the 50th anniversary of the Department of Health and Human Services (HHS), informational documents regarding HHS used in the drafting of the message, welcome home letters for new babies and adopted children, and administrative documents such as correspondence tracking sheets, printed emails, forms, and fax cover sheets.

System of Arrangement

The materials in FOIA 2017-0142-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files.

The White House Office of Records Management (WHORM) contains a variety of series created to organize and track documents and correspondence. The WHORM Subject Files and Alpha Files were compiled by staff in the White House Office of Records Management and are a series of documents assigned a letter/number combination and filed in a series of categories by subject. WHORM Subject Files and WHORM Alpha Files are processed at the document level.
