This FOIA primarily contains photographs of routine meetings related to homeland security, infrastructure, and cybersecurity, a press pre-briefing in the Oval Office, and staff portraits of Tom Bossert, Special Assistant to the President for Homeland Security and Senior Director for Preparedness Policy. Also included are photographs of a briefing on preparations for Hurricane Gustav and a visit to the Federal Emergency Management Agency (FEMA) Operations Center on August 31, 2008. In addition, there are photographs of Tom Bossert and family in the Oval Office with President George W. Bush.
