This FOIA primarily contains cover sheets, routing memos, draft and final correspondence between from Karl Rove and Harold Apolinsky regarding the death tax, handwritten notes, and a newspaper article regarding estate tax.

System of Arrangement

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM).

WHORM Subject and WHORM Alpha Files are processed at the document level.
