This FOIA primarily contains letters and other documents related to a potential veterans cemetery in Pennsylvania, a draft fact sheet on the White House Minnesota Conference on Faith-Based and Community Initiatives, a web page printout related to Archbishop James Michael Harvey, a biography of Henry Lozano, and Karl Rove's schedule for August 2, 2007.
