Scope and Content

FOIA 2017-0427-F requested materials related to records from the White House Council of Economic Advisers concerning the Homeland Investment Act, also referred to as Section 422: Incentives to Reinvest Foreign Earnings in the Unites States of the American Jobs Creation Act of 2004, HR 4520.

This FOIA primarily contains scheduling and administrative emails; articles; published reports, studies, and papers; legislative summaries, updates, and bills; daily tax reports; talking points and FAQs; congressional testimony; and the final 2009 Economic Report of the President.

System of Arrangement

The materials in FOIA 2017-0427-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
