Scope and Content

The materials in FOIA 2017-0434-F are a selective, not necessarily all inclusive, body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 2017-0434-F requested materials from Jay Lefkowitz's files related to prescription drugs, Part D, pharma, and the Medicare Prescription Drug, Improvement, and Modernization Act of 2003.

This FOIA primarily contains electronic records such as talking points, press releases, fact sheets, background papers, Q&As, articles, a Statement of Administration Policy on H.R. 2427, letters between the Administration and Congress, and emails from outside organizations. Records discuss Medicare reform, reimportation of drugs, and generic drugs between 2002 and 2003.

Please note that Jay Lefkowitz's Staff Member Office Files are already available under systematic processing.

System of Arrangement

The materials in FOIA 2017-0434-F are a systematic body of records responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – George W. Bush Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by President George W. Bush. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
